2. What data do we collect?

We may collect the following information from you:

Identity information including First name, Maiden name, last name, title, Gender, username or similar identifier, date of birth, marital status also any other information related to you

Contact information including email address; demographic information such as postcode, telephone number preferences and interests; and other information you provide to us in customer surveys, competitions and/or offers.

Historical Technical information based on information from your visit to any of our platforms by using your chosen browser and operating system or any other technology to access website

Transaction and financial information card details and account number for payment to and from you and other details of products and service you have purchased from us

Marketing Communication this to include preference in receiving marketing communication from us about products

3. What we use this data for?

Primarily we will use the data we collect to provide the Services. However we may also use this data for: internal analysis and statistics including demographics and page views; improving our products and services; sending you marketing communications and newsletters by email (when you have consented); and market research.

4. Disclosure of your personal data to third parties

Levant restaurant will never sell your data but will disclose it to suppliers such as email service providers.

We could potentially disclose data to potential buyers of any part of the business, and may be required to disclose data by law or court order.

5. Storage and security of your personal data

Your personal data is stored in electronic and physical records maintained by Levant restaurant and/or our service providers.
